

THE POOL DECK BIRTHDAY GIVEAWAY OFFICIAL RULES



No purchase necessary to enter or win. A purchase or payment of any kind will not increase your chances of winning. void where prohibited or restricted by law.

1. SPONSOR

The Pool Deck Birthday Giveaway (the “Sweepstakes”) is sponsored by Skimmer, LLC, 728 Northwestern Avenue, B, Austin, Texas 78702 (“Sponsor”).

2. ELIGIBILITY

The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older as of the start of the Sweepstakes Period. Employees, officers, directors, and contractors of Sponsor, its parent companies, subsidiaries, affiliates, and advertising and promotion agencies, and the immediate family members (spouse, parent, child, sibling, and their respective spouses) and members of the same household of each are not eligible to participate. Void where prohibited or restricted by law.

No purchase, payment, or Skimmer customer status is required to enter or win.

3. SWEEPSTAKES PERIOD

The Sweepstakes entry period begins at 3:00 PM Eastern Time on Wednesday, May 27, 2026 and ends at 11:59 p.m. Eastern Time on Thursday, July 2, 2026 (the “Sweepstakes Period”). Sponsor’s computer is the official time-keeping device for this Sweepstakes.

4. HOW TO ENTER

To enter, complete and submit the official online entry form available at www.thepooldeck.getskimmer.com during the Sweepstakes Period. All required fields must be completed and submitted in accordance with the on-screen instructions.

Limit one (1) entry per person and per email address during the Sweepstakes Period. Multiple entries from the same person or email address will be disqualified. Use of any robotic, automatic, programmed, or other automated entry method, or entering more times than permitted, will void all entries and result in disqualification. Entries submitted by any means other than the official online entry form will not be accepted. Incomplete, illegible, or late entries will be disqualified.

Instagram, Facebook, and LinkedIn are not sponsors of, administrators of, or affiliated with this Sweepstakes.

5. PRIZES

Two (2) prize packages will be awarded. Each prize package consists of the following:

- a. Round-trip economy airfare for one (1) person to San Antonio, Texas from the major commercial airport nearest to the winner’s primary U.S. residence. Airfare valued up to \$1,000. Actual value will depend on point of

departure and time of booking. Any difference between stated value and actual cost will not be awarded.

- b. Three (3) nights single-occupancy accommodation at the San Antonio Marriott Riverwalk (or a substantially comparable hotel selected by Sponsor). Check-in available Thursday, October 15, 2026 or Friday, October 16, 2026 (winner's election); check-out Sunday, October 18, 2026. Approximate retail value: \$835.
- c. One (1) prepaid gift card. Approximate retail value: \$200.

Approximate retail value ("ARV") per prize package: \$1,935. Total ARV of all prizes: \$4,070.

Each winner will also receive complimentary admission to the Skimmer Pro Summit on Friday, October 16 and Saturday, October 17, 2026 in San Antonio, Texas. Admission to the Skimmer Pro Summit is provided by Sponsor to all attendees free of additional charge and is not included as a stated component of the prize package.

The prize is for one (1) person only. Travel companions are not included in the prize. Any companion accompanying a winner does so at the winner's sole expense; if a companion shares the hotel room provided as part of the prize, no separate room or accommodation will be provided by Sponsor.

6. WINNER SELECTION AND NOTIFICATION

Two (2) winners will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The drawing will be conducted by Sponsor on or about Friday, July 3, 2026. Odds of winning depend on the number of eligible entries received.

Potential winners will be notified by email at the address provided at the time of entry. Sponsor is not responsible for any failure of a potential winner to receive notification due to spam filters, incorrect or non-functioning contact information, or other technical issues.

Potential winners must respond to the notification within five (5) business days of the date the notice is sent, or such longer period as Sponsor may grant in its sole discretion. Failure to respond within the applicable time-frame, failure to meet any eligibility requirement, the return of any notification as undeliverable, or non-compliance with these Official Rules may result in disqualification, and an alternate winner may be selected in a random drawing from the remaining eligible entries.

7. AFFIDAVIT, RELEASES, AND TAX DOCUMENTATION

As a condition of receiving the prize, each potential winner will be required to complete and return an Affidavit of Eligibility, Liability Release, and Publicity Release within five (5) business days of receipt, or such longer period as Sponsor may grant in its sole discretion.

Each potential winner will also be required to submit an IRS Form W-9 (Request for Taxpayer Identification

Number and Certification) before the prize is awarded. Sponsor will issue an IRS Form 1099-MISC to each prize winner reflecting the approximate retail value of the prize received. All federal, state, and local taxes on the prize are the sole responsibility of the winner.

8. ATTENDANCE AT THE SKIMMER PRO SUMMIT

Each winner is expected to attend the Skimmer Pro Summit on October 16–17, 2026 in San Antonio, Texas in order to redeem the travel and accommodation components of the prize. If the Skimmer Pro Summit is cancelled, postponed, materially altered, or otherwise rendered unavailable for any reason, Sponsor will, in its sole discretion, provide each prize winner with a substitute prize of comparable value or such other accommodation as Sponsor determines is reasonable under the circumstances. Sponsor’s decision in all such matters is final and binding.

10. PRIVACY

Personal information collected through the entry form will be used solely for the purpose of administering the Sweepstakes, including verifying entrant eligibility, conducting the random drawing, notifying potential winners, awarding prizes, and complying with applicable tax reporting requirements. Sponsor will not use entry information for any other marketing or commercial purpose.
